Membership and SLE Church

Pastor Steven presented a draft document outlining a biblical vision for meaningful church membership at SLE. The presentation explored themes of belonging, accountability, pastoral care, and covenantal commitment, drawing from Acts 2, 1 Peter 5, and Hebrews 13, and Galatians 6. Members engaged warmly with the discussion, expressing appreciation for the clarity, theological grounding, and a more rich expression of church membership.

The session emphasized that membership is not merely formal but a visible, relational structure of care—where members are known, shepherded, and active in building up the body of Christ. The proposed covenant aims to express gospel truth together and clarify who we are in Christ as a church family.

Next Steps:

- Ps Steve will rework the presentation into a booklet for members, including the five Theological Distinctives of SLE.
- The draft covenant will be reviewed by the elders before formal rollout.
- Future members will receive and affirm the covenant upon joining.
- Membership processes, previously paused, will resume with renewed clarity and intentionality.
